## INFOSERVE INC. - NATIONLINK e-Money Terms and Conditions



<u>Definition of Terms</u>
a. PIN – Personal Identification Number. It is the confidential number used to perform PIN – Personal ATM functions.

ATM – Automated Tellering Machine. It is a computerized telecommunications device that provides the cardholder access to financial transactions in a public space without the need of a human clerk or bank teller.

POS – Point of Sale. It is a check-out counter in a shop or the location where a

transaction occurs.

NLPAY – NATIONLINKPay Cash-in/Cash-out station.

NATIONLINKPAY AGENT – Any authorized agent to operate NATIONLINKPay Cash-in/Cash- out station/ and/or authorized outlet for NATIONLINK e-Money

Description of the INFOSERVE INC. - NATIONLINK e-Money Card

a. The INFOSERVE INC. - NATIONLINK e-Money Card is a pre-activated, reloadable, multi- purpose electronic value card.

b. The INFOSERVE INC. - NATIONLINK e-Money Card functions like a regular ATM
Card. You may withdraw from any INFOSERVE INC. - NATIONLINK Network
ATM or any accredited ATM bank consortium in the Philippines after PIN
verification. The INFOSERVE INC. - NA-TIONLINK e-Money Card may be used
as a purchase card. It is honored at BancNet-POS accredited merchants and
INFOSERVE INC. - NATIONLINKPay Cash-in/Cash-out stations with electronic
terminals in the Philippines after PIN verification.

c. The INFOSERVE INC. - NATIONLINK e-Money Card is not a savings account,
therefore, does not earn interest. It is not insured by the Philippine Deposit
Insurance Corporation (PDIC) and not subject to a minimum maintaining balance.

- Uses of the INFOSERVE INC. NATIONLINK e-Money Card

  The INFOSERVE INC. NATIONLINK e-Money Card maybe used to withdraw cash through any ATM or INFOSERVE INC. NATIONLINK e-Money Card maybe used to withdraw cash through any ATM or INFOSERVE INC. NATIONLINK Network Cash-in, Cash out stations. The maximum withdrawable amount per day is twenty thousand pesos (P20,000.00) or any other amount as may be set by INFOSERVE INC. NATIONLINK in the future. From a minimum of one hundred pesos (P100.00) you can withdraw up to a maximum of ten thousand pesos (P10,000.00) per transaction. Up to a maximum of five (5) ATM transactions per day is allowed but not to exceed the maximum withdrawable value per day of twenty thousand pesos (P20,000.00), whichever comes first. The e-Money operations are fullyreliant on the IN-FOSERVE INC. NATIONLINK Network operations and systems. In case the INFOSERVE INC. NATIONLINK Network operations and systems is unavailable the e-Money card holder cannot transact in any other way.
